Attendance

Attendance is key to making good progress at secondary school. Please do let us know if there is any support required to deal with any absence your child might be experiencing. At the end of last term our Education Welfare Officer, Helen Priestley, joined the Trust and I know she has reached out to many families to support in resolving absence. You can monitor your child's attendance to the academy and to lessons using the Satchel One App. Please do let us know if you have not yet accessed that system and would like support in that regard.

At the academy, we recognise that there are occasions when it is appropriate to authorise an absence, such as when a student is genuinely too ill to attend school, has a medical appointment that cannot be taken outside of school hours or a request for leave has been agreed in exceptional circumstances. However, the Government does not support parents/carers taking children out of school unless the school agrees this is appropriate under 'exceptional circumstances'. Any request for leave should be made in writing to myself using the form available on the attendance area of our website.

If you decide to still take your child out of school, without permission, you will be committing an offence under the Education Act 1996. We may refer the matter to Cornwall Council who may decide to take legal action against you. A penalty notice can be issued under Section 444A and 444B of the Education Act 1996. This carries a fine per parent, per child of £60 if paid within 21 days or £120 if paid after this but within 28 days. Failure to pay the penalty notice may result in Court action. Persistent absences not authorised by the school may result in a prosecution in the Magistrates' Court, leading to fines up to £2,500 and/or custodial sentences. The Council may also apply for the costs incurred in taking the matter to Court. You are welcome to contact the academy to discuss any concerns you may have regarding this or if you feel you would like advice or support in helping your child attend more regularly. The academy is committed to maximising the education of all its students and aims to work with parents and carers to ensure this can be achieved.

This will be a busy and exciting term with lots of opportunities ahead as we prepare Year 10 and 11 for their exams and finish the year with Challenge Week.
